COMES NOW, Jeffrey DeNunzio, the appointed custodian of CHINA SHOUGUAN INVESTMENT HOLDING GROUP CORP. who hereby submits this Quarterly Report as requested by this Court through its Order dated December 2, 2020.

1. Jeffrey DeNunzio was previously appointed by this Court as Custodian of CHINA SHOUGUAN INVESTMENT HOLDING GROUP CORP. on November 23, 2020, pursuant to NRS §78.347.

2. On or about October 19, 2020, Petitioner brought this action as a shareholder of the Corporation seeking appointment of Jeffrey DeNunzio as Custodian of the Corporation because, among other things, the Corporation had allowed its charter with the State of Nevada to lapse by failing to file the required annual reports and to pay the required annual fees.

3. The last known officers and directors reflected in the records of the Nevada Secretary of State ("NVOS") did not object to Plaintiff's Petition, nor did any of the last known shareholders.

3 4. Plaintiff's Motion for entry of default judgment was unopposed and an Order for Default Judgment was
4 entered on December 2, 2020.

5 5. Custodian subsequently filed a Certificate of Amendment to Articles of Incorporation and a Certificate of
6 Reinstatement and remitted payment to bring the Corporation current with Nevada Secretary of State and
7 retained a registered agent.

8 6. Custodian appointed himself as the interim President Secretary and Director of the Corporation, subject to
9 election of a Board of shareholders pursuant to NRS 78.347.

10 7. Custodian has attempted to locate the former corporate books and records and to identify the assets and
11 liabilities of the Corporation. As of this writing, Custodian has been unable to locate any of the former assets,
12 including books and records of the Corporation.

14 8. The Custodian located Equiniti Stock Transfer, the Corporation's transfer agent and has now settled the
15 outstanding amount due and owing to the transfer agent. The transfer agent has provided a shareholder list to
16 the Custodian. The Custodian plans to hold a shareholder meeting soon. To date, Custodian has not heard
17 from the previous management.
